REBATE Qualifications

- **Customer MUST have an active account and at least 12 months of billing history at the current business address**
- **The electric forklift must be registered within Colton Electric Utility service territory**
- **The incentive offer is on a first-come, first-served basis and is effective until the program is fully subscribed or the program is discontinued**
- **If installing a charger on property, applicant is responsible for obtaining all required permits from the City of Colton* (when applicable)**
- **Colton Electric Utility does not warrant, endorse or assume liability for the quality, performance, or safety of the contractor and/or retailer or wholesaler. Performance of any product and acceptance of materials used is solely the customers responsibility**
- **Applicant is responsible for meeting all program requirements and for checking with State/County/City governments and homeowners associations (if any) regarding local conditions, restrictions, codes, ordinances, rules and regulations prior to installation**
- **Maximum of one electric forklift rebate per business**

APPLICATION REQUIREMENTS

- This signed and dated application, copies of sales receipt and pictures must be sent to Colton Electric Utility.
- I am responsible for filling out the application completely, truthfully and accurately.
- I understand that Colton Electric Utility is not responsible for items lost or destroyed in the mail/transit.

PAYMENT

- Payment of the rebate is conditional that all supporting documentation be submitted with the application. Delays in proper documentation will delay the rebate delivery.
- Colton Electric Utility will mail rebate checks greater than \$500 for qualifying items within six weeks of receiving a completed application. For rebates less than \$500, a credit will be placed on the customers utility account within 2-3 billing cycles.
- The rebate is not to exceed the total cost of the unit, installation, and building permit fees combined.
