Planning Commission meeting agenda packets are available for public review no later than the end of the day on the Thursday the week before the meeting online on the city website (on the home page - www.coltonca.gov - click on “Minutes & Agendas” icon box at the far right) or at: <http://www.coltonca.gov/agendacenter>. Below are deadlines for application filing and the corresponding earliest possible staff-level Application Review Committee (ARC) meetings; the ARC meetings are not open to the public. A Planning Commission public meeting **may** be held on the corresponding date shown below if no additional items, including meeting the criteria below, are required for consideration of an application.

1. The submittal requires no additional information (including revised plans) to deem the application complete (after application review by City departments).
2. The application is exempt from the California Environmental Quality Act (CEQA) - i.e. does not require an Initial Study to assess potential environmental impacts.
3. The application does not involve applications (such as conditional use permits or variances) that require public noticing (newspaper and/or mailing) beyond the meeting agenda. *(If noticing is required and the other assumptions are met, the Planning Commission meeting may be deferred to the next available meeting date.)*

Be advised that on certain dates (shown in **boldface** type), meetings have been moved due to the closure of City offices for holidays.
